

***Adopt a Dinosaur Certificate Generator***  
**“TERMS AND CONDITIONS”**

By using the “*Jurassic World: Fallen Kingdom*” (the “**Film**”) “*Adopt A Dinosaur*” certificate generator application on the Film’s web site located at [www.AdoptADinosaur.com](http://www.AdoptADinosaur.com) (“**Website**”) and uploading a photo (the “**Photo**”) to the Website for inclusion in the symbolic dinosaur “Certificate of Adoption” (the “**Certificate**”) and/or sharing the Certificate through your personal social media account(s) including, without limitation, Twitter, Facebook and Instagram (“**Social Media**”), you hereby agree to the following terms and conditions:

**1. SUBMISSION GUIDELINES:** You represent and warrant that the Photo and entries on the Certificate comply with the following:

- (a) Your Photo is original and does not infringe the copyright, trademark, privacy, publicity, or other personal or proprietary rights of any person or entity.
- (b) You must have the permission of any person who appears in your Photo or who you identify or otherwise refer to in your Photo. **In order to participate, you must be at least thirteen (13) years old. If you are a minor, your Photo and entries on the Certificate must be submitted by your parent or legal guardian and you must have the consent of the parent or legal guardian of any other minor who appears in your Photo.**
- (c) Your Photo does not contain or reference any brand names, products or services of any company or any third party trademarks, copyrights, logos, trade dress or promotion of any brand, product or service.
- (d) Your Photo must not contain any personal information (e.g., your name, e-mail address or phone number); if your Photo contains personal information, it is your sole responsibility to remove all such personal information from the Photo before uploading the Photo to the Website or posting it in Social Media.
- (e) Your Photo and entries on the Certificate do not contain content, images or other material that (i) is misleading, inappropriate, indecent, lewd, obscene, offensive, sexually explicit, pornographic, harmful, tortious, disparaging, defamatory, slanderous or libelous, (ii) depicts an unsafe practice or activities that are restricted, prohibited, illegal or in violation of or contrary to any applicable federal or state laws or regulations (including without limitation, the consumption of alcohol or any other controlled substances), or (iii) reflects, advocates or promotes bigotry, racism, hatred, harm or exploitation of or against any class, group or individual, discrimination based on race, gender, religion, nationality, disability, sexual orientation or age.
- (f) Your Photo is submitted in compliance with the format and other terms and conditions set forth on the Website and applicable Social Media accounts used to share your Photo; such requirements being made a part of these Terms and Conditions and incorporated herein by reference.
- (g) You agree to indemnify Universal Pictures Marketing, a division of Universal Film Exchanges LLC (“**Universal**”) for all damages and expenses (including reasonable attorney’s fees) arising out of any breach or failure of the representations or warranties made by you herein.

**2. GRANT OF RIGHTS:** By creating a Certificate and/or sharing it to your Social Media accounts you hereby grant to Universal and its designees (and represent and warrant that you have obtained all rights necessary to grant the license with respect to the Photo herein described, including from the photographer or owner of the photograph used in the Photo, if other than you) a royalty-free, irrevocable, perpetual, worldwide, sub-licensable, non-exclusive license (herein “**License**”) to publish, display, reproduce, post, edit, adapt, modify, make derivative works therefrom, use or otherwise exploit your Photo and Certificate entries including, without limitation, your name, image, likeness, voice, performance, and all other information or material contained therein, in any way, in any manner and on any media now known or hereafter devised, without notice, credit or compensation, for any purpose in connection with the Film and/or the advertising, promotion and publicity of the Film. The foregoing grant of rights includes, without limitation, the right of Universal to use your Photo on the Film’s Website and in digital and social media accounts for the Film. You represent and warrant that you have the sole and exclusive right to grant such rights to Universal, its licensees, successors and assigns and that the reproduction, publishing, displaying, and/or other use of your Photo and Certificate entries by Universal

reproduction, publishing, displaying, and/or other use of your photo and Certificate entries by Universal, its licensees, successors and assigns will not infringe on any rights of third parties, including, without limitation, copyright, trademark, patent, privacy, or publicity, or create claims for defamation, false light, idea misappropriation, intentional or negligent infliction of emotional distress, or breach of contract. Nothing in these Terms and Conditions obligates or may be deemed to obligate Universal or any other person or entity to exercise any of the rights granted by you hereunder. Universal reserves the right to remove any Photo and/or Certificate that does not comply with these Terms and Conditions or meet Universal's standards for any reason, as determined by Universal in its sole discretion.
